Jury Cuts Down Damages
Claimed by Lifschitz
Brothers from P. S. C.

Claims made by Samuel and Jacob Lifschitz for injuries resulting from an accident due to the negligence of the Public Service Railway Company, were considerably reduced by a jury in the District Court yesterday afternoon, when a verdict of \$150 for Jacob and \$100 for Samuel was returned instead of \$300 and \$500 claimed respectively.

The company admitted liability for the accident, which was a collision between the plaintiff's wagon and a trolley car at Yates' Corner, but it was claimed that the damages claimed were exorbitant. Physicians testified that Samuel was not seriously injured and that his claim for the pain and suffering he endured was beyond reason.

It was also claimed that Jacob's horse was not injured as badly as he claimed, and the jury apparently took this view of the case as shown by the verdict. Former Judge Colt, of Newark, represented the company, while Mr. Gleckfeld, of Alfred S. March's office, appeared for the plaintiffs.

The case was tried by a six man jury, which was composed of Charles Kuhitham, Lewis Stokes, Patrick J. Moran, Eugene McLaughlin, John Forman and H. B. Blaine. The jury was out about half an hour before a verdict was agreed upon. Before retiring they asked for a written list of the items of claim, which was granted them by consent of counsel, although Judge Woodbridge remarked that it was a rather unusual proceeding.

JOHN W. METTLER

MADE TRUSTEE FOR
LIFE BY RUTGERS

John W. Mettler, of New Brunswick, president of the Interwoven Stocking Company, was elected trustee for life of Rutgers College yesterday afternoon by the Board of Trustees at their monthly meeting. J. Amory Haskell, of New York, was also elected a life trustee.

The election of Mr. Mettler came as the result of his long work on behalf of the college in many ways and his close connection with movements that have been started in the interests of the local institution. He graduated from Rutgers in 1899, and in 1902, after being given a degree of LL.B. at New York Law School, he was made a Master of Science by Rutgers.

Since that time he has always been closely associated with Rutgers College, and has been mentioned several times before for a trusteeship, but owing to his extensive business interests he was unable to devote the time necessary. Mr. Mettler, besides heading the Interwoven Company, the largest manufacturers of men's hose in the world, is president of the Kilbourn Knitting Machine Company, which he founded in 1905.

He spends much time in New York City, but he maintains his old home at East Millstone, and also has a summer residence at Spring Lake. He is a member of the New York Chamber of Commerce, the University Club, the Rutgers Club and the New Brunswick Country Club.

Mr. Haskell, who was also elected yesterday, has extensive manufacturing interests in New York and elsewhere, and is associated with several powder making firms. The acquisition of these two men will be a big asset to the Rutgers trustees and will be a big benefit to the college.

Plans for the celebration of the 150th anniversary of the college next fall were also discussed, and it was stated that tentative plans are being made for a campaign to raise a big endowment fund for the college in connection with the anniversary.
